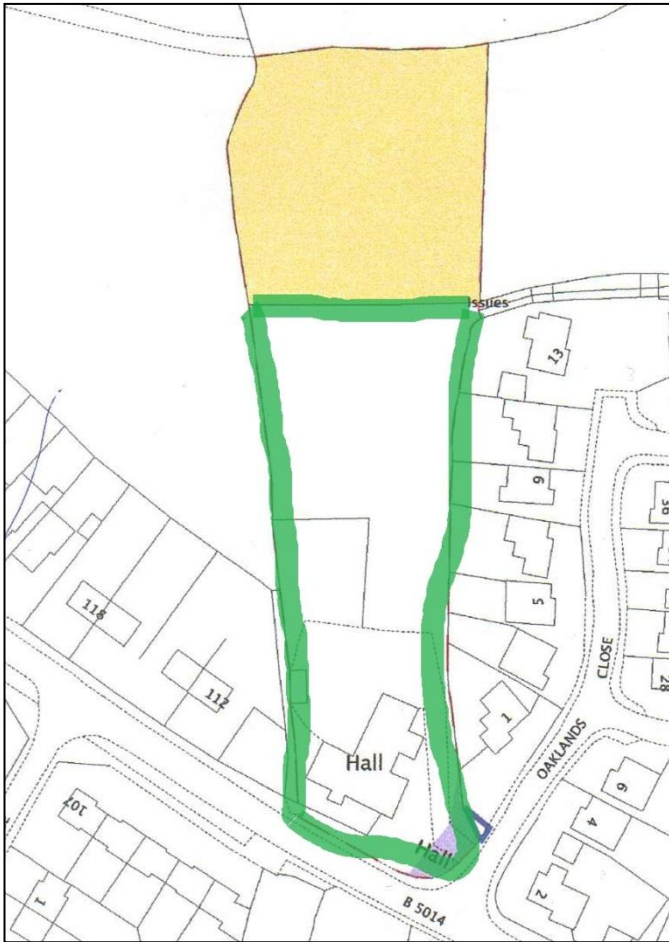

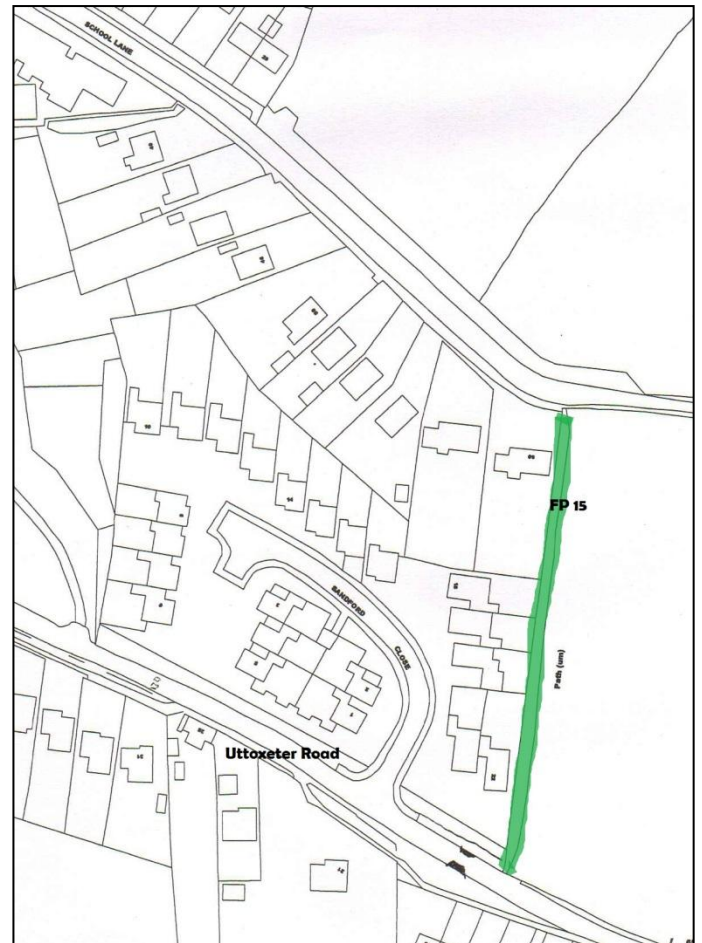
1. TO MOW THE PLAYING FIELD AROUND THE FENCED PLAY AREA AND THE PERIMETER AND PATHS OF THE ALLOTMENTS AT THE REAR OF THE VILLAGE HALL TWICE A MONTH BETWEEN MARCH – OCTOBER (TOTAL 16 CUTS). MOWN GRASS HAS TO BE REMOVED FROM SITE. (MAP 1)
2. WEEDING THE PLAY AREA AND APPLYING WEED PREVENTION TREATMENT ON THE PLAY AREA PERIMETER. (MAP1)
3. TO CUT THE HEDGE AT THE REAR OF THE PLAYING FIELD NEXT TO THE ALLOTMENTS AND THE HAWTHORN HEDGE NEXT TO THE PEDESTRIAN ACCESS GATE, ONCE A YEAR IN FEBRUARY. (MAP 1)
4. TO STRIM FOOTPATH NO. 15 WHICH GOES BETWEEN SCHOOL LANE AND UTTOXETER ROAD – ONCE PER MONTH IN APRIL, MAY, JUNE, JULY, AUGUST, SEPTEMBER & OCTOBER. (MAP 2).
5. TO CUT BACK OVERHANGING BRANCHES ON FOOTPATH NO 14 WHICH GOES BETWEEN UTTOXETER ROAD AND HAWKHURST DRIVE TWICE ANNUALLY IN MAY AND AUGUST. (MAP 4).
6. TO STRIM FOOTPATH NO 25 WHICH GOES BETWEEN THE UTTOXETER ROAD AND SCHOOL LANE BUT JUST THE “MOUTH” OF THE FOOTPATH (MARKED IN RED ON MAP 3) TWICE ANNUALLY IN MAY AND AUGUST.
7. TO CARRY OUT ADDITIONAL CUTS UPON REQUEST, CHARGED AT AN AGREED UNIT COST SUPPLIED AS PART OF THE QUOTE FOR EACH OF THE ITEMS ABOVE.
8. TO PROVIDE A SCHEDULE OF CUTTING DATES TO SATISFY THE TERMS ABOVE.
9. TERM OF THE CONTRACT TO RUN FROM 1ST JANUARY 2027 TO 31ST DECEMBER 2029.
10. THE COUNCIL RESERVES THE RIGHT TO TERMINATE THE CONTRACT AFTER 12 MONTHS IF WORK IS UNSATISFACTORY.
11. THE PROVIDER MUST PROVIDE EVIDENCE OF LIABILITY INSURANCE AND REFERENCES FROM EXISTING CUSTOMERS.

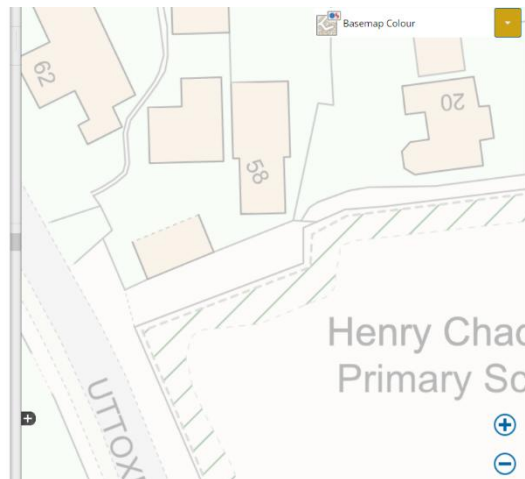
Map 1 – Village Hall
